Global sea level is projected to rise another one to four feet by 2100. Sea level rise poses substantial risks, including greater vulnerability to severe coastal flooding.”

Correction: Change “2011” to “1911”

New Mexico

Error (2019 Summary, PDF and WEB): Figure 1 states temperature increase is “about 2°F.”

Correction: Change third sentence in Figure 1 caption to read “Temperatures in New Mexico (orange line) have risen 2°F since 1900.”

North Carolina

Error (2019 Summary, PDF and WEB): Temperature increase is stated as “almost 1°F” in first key message, Figure 1 caption, and first sentence of second paragraph.

Corrections: In the first key message, delete “by almost 1°F since the beginning of the 20th century.” and replace with “1.1°F since 1900.” In the Figure 1 caption, delete “almost 1°F since the beginning of the 20th century.” and replace with “1.1°F since 1900.” In the first sentence of paragraph 2, delete “**almost 1°F**” and replace with “**1.1°F**” (note boldfacing).

Error (2017 Summary, PDF only): Figure 1 caption states: “Projected changes for 2015–2100...”

Correction: Change to “Projected changes for 2006–2100...”

Oklahoma

Error (2017 Summary, PDF only): Figure 3a title is given as: “Observed Number of Hot Days”

Correction: Change to “Observed Number of Extremely Hot Days”

Rhode Island

Error (2017 Supplemental Figures PDF): Supplemental Figure 15 is titled “Average Daily Minimum Temperature—Fall”

Correction: Change “Fall” to “Summer”

Tennessee

Error (2017 Summary PDF and WEB): The third sentence of the Figure 1 caption gives an incorrect year range. It states “2015–2100”

Correction: Change to “2006–2100”

Error (2017 Summary, PDF and WEB): The first sentence of the Figure 5 caption gives an incorrect year range. It states “1950–2014”

Correction: Change to “1900–2014”



Utah

Error (2017 Summary, PDF only): Figure 4 caption states: “CICS-NC and NOAA NCEI.”

Correction: Change to “Source: CICS-NC, NOAA NCEI, and SNOTEL.”

Washington

Error (2017 Summary, PDF only): Key Message 1 states: “Mean annual temperature has increased approximately 1.5°F over the last two decades.”

Correction: Change to “Mean annual temperature has increased approximately 1.5°F since the beginning of the 20th century.”

Error (2017 Summary, PDF only): Figure 4 caption states: “Source: SNOTEL.”

Correction: Change to “Source: USDA Natural Resources and Conservation Service.”
